Supporting documentation (e.g., copy of the obituary, notice of the funeral, or death certificate).</li> <li>3. Supporting documentation that demonstrates your ability to return to classes and complete your coursework successfully (e.g., letter of support from professional counseling and consultation, physician's statement).</li> </ol>
Recent Serious Illness or Injury to Student	<ol style="list-style-type: none"> <li>1. A detailed explanation of the medical circumstances, including the date of occurrence, duration, and how it negatively affected your academic success.</li> <li>2. Supporting documentation (e.g., physician's statement, copy of police report).</li> <li>3. Supporting documentation regarding what steps you've taken to improve your ability to complete your coursework successfully (e.g., physician's statement or third-party agency that assisted you during your illness or injury).</li> </ol>
